Medical Council of New Zealand and ECFMG Announce Partnership

WELLINGTON, NEW ZEALAND and PHILADELPHIA, UNITED STATES—November 15, 2017. The Medical Council of New Zealand (Council) and the Educational Commission for Foreign Medical Graduates (ECFMG®) are pleased to announce their collaboration to incorporate ECFMG’s Electronic Portfolio of International Credentials (EPICSM) into the Council’s process for assessing international medical graduates (IMGs). Effective November 1, 2017, first-time applicants for medical registration, and (in some cases) doctors already registered with the Council but applying for a new scope of practice, are required to have their medical qualifications primary-source verified through EPIC if their application relies on a primary medical qualification from either an institution outside New Zealand or a postgraduate qualification conferred by an institution other than a New Zealand or Australasian training provider.

The Medical Council of New Zealand is charged with protecting the health and safety of New Zealand’s public. Registration with the Council is a requirement for all doctors who practise medicine in New Zealand. ECFMG is proud to partner with the Council to add primary-source verification—a best practice and the best protection against fraudulent credentials—to the Council’s tools for evaluating doctors’ qualifications. William W. Pinsky, M.D., President and CEO of ECFMG, noted “Evaluating doctors’ medical credentials is essential to the work that medical regulatory authorities perform in their efforts to promote quality health care and protect the public. ECFMG is pleased to be able to provide enhanced support to the Council’s evaluation process through EPIC.”

Philip Pigou, CEO of the Medical Council of New Zealand said “Primary-source verification is a further tool for the Council to ensure that all doctors practising in New Zealand are who they say they are, and have the qualifications they claim to have. This will add further rigour into Council’s processes for assessing IMGs.”

EPIC offers primary-source verification of medical credentials—verifying the authenticity of a credential directly with the issuing institution—to organizations and medical doctors worldwide. EPIC employs the same world-class, primary-source verification process used by ECFMG to verify credentials for other ECFMG services, including ECFMG Certification, the standard for international physicians entering the U.S. health care system. EPIC offers organizations secure, no-cost access to primary-source verification. For physicians, EPIC is an innovative way to build a digital career portfolio of the credentials related to their medical education, training, and registration/licensure—a portfolio that can grow with their careers.
